DEED OF GIFT AND AGREEMENT BETWEEN	AND ART CONNECTION-R	J

"Artist/Donors" (as listed below) gives to ("Donee"), the works of art described on the attached **Exhibit A** (the "Artwork")

In consideration of the acceptance of this gift by Donee, Artist/Donor covenants with Donee that Artist/Donor is the lawful owner of the Artwork, that no one but the Artist/Donor has any claim of ownership to or lien encumbering the Artwork, that Artist/Donor has good right and title to give the Artwork to the Donee, and that the Artist/Donor will hold the Donee harmless from the lawful claims and demands of all persons resulting from or arising out of a breach of said covenants.

In consideration of its receipt of the Artwork, Donee agrees:

- to take reasonable precautions to protect and preserve the Artwork in perpetuity.
- to exhibit the Artwork where it may be viewed by the public, or those persons served by the Donee;
- not to permit the Artwork to be altered or defaced;
- not to sell or dispose of the Artwork {without first obtaining the consent of the Donor, which consent shall not be unreasonably withheld};
- to notify Art Connection-RI and the Artist/Donor if artwork is damaged, lost, or misused
- to notify Art Connection-RI and the Artist/Donor of any address change for the Donee; and
- to notify Art Connection-RI and the Artist/Donor of any change in the Donee's charitable status, or if the Donee is merged, dissolved, or terminated, and, in the event of such merging, dissolution, or termination, either
 - (a) to donate the Artwork to a suitable ongoing charitable organization, with the consent of the Artist/Donor (or the consent of Art Connection-RI), such consent not to be unreasonably withheld; or
 - (b) to promptly return the Artwork to the Artist/Donor or to Art Connection-RI, whereupon the Artwork will be made available for selection by another charitable organization.

Donee further agrees not to permit the Artwork to be reproduced without the Artist/Donor's written permission, and to abide by any special restrictions listed on **Exhibit B** attached hereto.

Donee certifies that it currently qualifies as a tax-exempt charitable recipient under Section 170 of the Internal Revenue Code.

Donee hereby acknowledges receipt of the Artwork; however, Donee also acknowledges that Donee receives no copyright interest in or to the Artwork.
